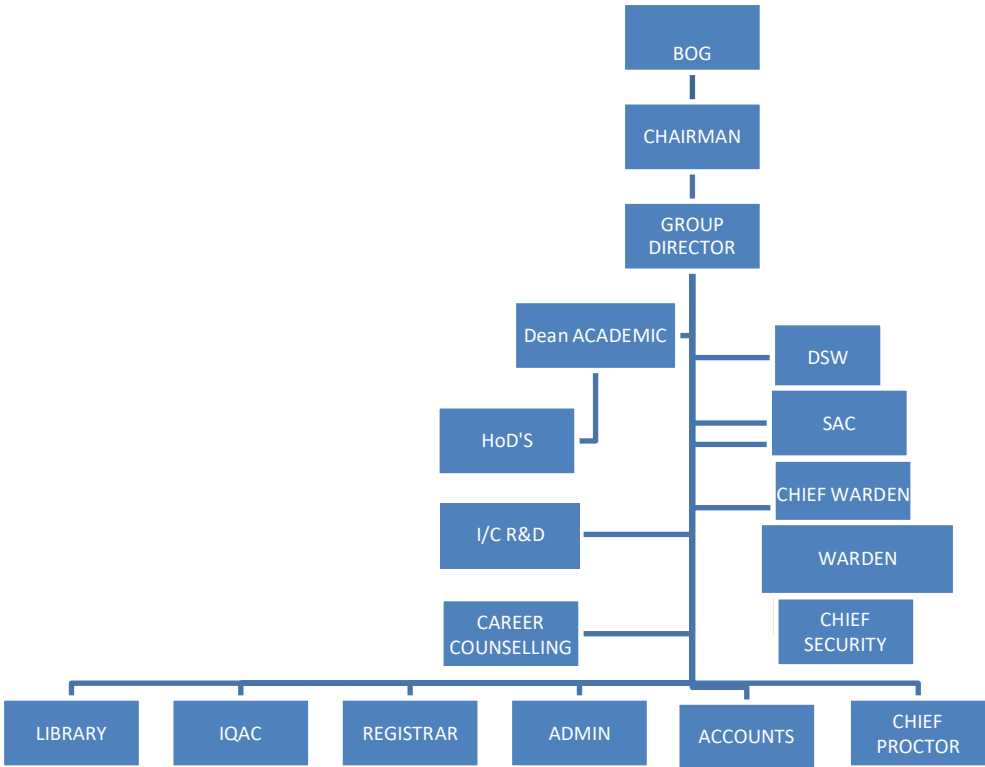

AND WHEREAS, **C-Core India Techno solution Pvt Ltd**, is a registered company, AND WHERE both “**SRGI JHANSI** ” and **C-Core India**

Technosolution Pvt Ltd are desirous of associating with each other to expertise students of SRGI Jhansi will also help in conducting Expert Lectures/Seminars/Workshops/Internship/Industrial Visits/Consultancy (keep appropriate) as an addition to SRGI JHANSI curriculum in co-ordination with SRGI JHANSI Faculties & HoD.

Now therefore, in consideration of the premises and the actual covenants herein contained, it is agreed by both **SRGI JHANSI** and **C-Core India Technosolution Pvt Ltd** as under.

Definitions and Interpretation

Use of words in the singular includes the plural and vice versa and the masculine gender includes the feminine where applicable.

Where a word or phrase is defined, other parts of speech and grammatical forms of that word or phrase shall have the corresponding meanings. Any reference to ‘Writing’ includes printing, typing, lithography and other means of reproducing words in visible form.

C-Core India Technosolution Pvt Ltd shall be responsible for arrangements & co-ordination for supply of Industry Expertise, Design training programme, Process of necessary Appointments with Industries for



Industry Internship Program, Expert Lectures as well as Visits in co-ordination with staff & HoD of SRGI JHANSI .

SRGI JHANSI shall create awareness amongst its students for promotion of the activity especially Internship Program.

4.0 Certification

4.1. Upon completion of the Internship, C-Core India Technosolution Pvt Ltd & SRGI JHANSI will jointly conduct technical assessment for students. The students qualifying the technical assessment shall be certified with completion certificate.

5.0 Relationship

This MOU relates solely to the intention of the parties, wherein SRGI JHANSI and C-Core India Technosolution Pvt Ltd jointly work together and shall not extend to any other activity or create a partnership between the Parties hereto and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in their respective fields, except to the extent expressly provided herein.

6.0 Authority to Bind

No party shall act on behalf of the other party to contractually bind the other Party under the terms of this MOU having first obtained the other Party's written agreement.

Confidential and Proprietary Information

"Confidential Information" shall mean all information, including the material and licenses or other information if any so given to **SRGI JHANSI**, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by **C-Core India Technosolution Pvt Ltd** and disclosed by **C-Core India Technosolution Pvt Ltd** to **SRGI JHANSI** or its faculty which is related to **C-Core India Technosolution Pvt Ltd** information such as course material, training data, guidance notes, procedures, methodology, etc.

SRGI JHANSI shall hold in trust and confidence for **C-Core India Technosolution Pvt Ltd** all confidential information provided by **C-Core India Technosolution Pvt Ltd** and **SRGI JHANSI** shall not disclose to any person or use such information for any purpose other than defined in this MOU. **SRGI JHANSI** shall not make any copies of the confidential



information other than are required for the work involved and with prior and mutual consent from **C-Core India Technosolution Pvt Ltd** and shall return/destroy all such information at the termination of the contract. 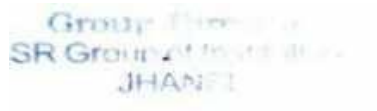



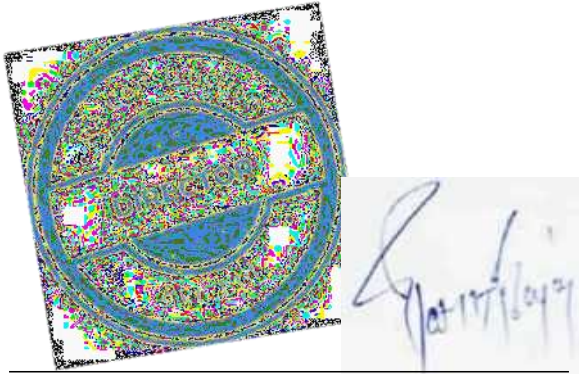

The technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses / programs being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education. The mandatory disclosure information, as per directions in the AICTE website / Approval Process Handbook, shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the institution.
15. It shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place.
16. If a technical institution fails to disclose the information or suppress and / or misrepresent the information, appropriate action as per the notified regulations shall be initiated against the institution.
